[REDACTED] members of the COS will participate in any activity to pursue this goal. [REDACTED] could not state any specific illegal activities being participated in to pursue this goal.

[REDACTED] "clearing" the planet means converting all people to the COS and proving that all other leaders, governments and religions are misused by people as crutches. [REDACTED] the COS misrepresents that it is an interdenominational religion which accepts all creeds. [REDACTED] the COS only accepts their creed and that L. RON HUBBARD eventually declared himself to be the "Messiah." These statements can be found in the training course known as "Operating Thetan VIII," also known as OT VIII.

[REDACTED] "Third Class Mission Trained." People trained in this mission status are trained to follow all orders. These people are also trained to never incriminate the COS if they are caught committing an illegal act. These people are trained to either commit suicide if captured, or to state that they defected from the COS and are committing criminal acts on their own. Third Class Mission Trained SEA ORG members are trained to "terminatedly handle" situations and people. "Terminatedly handle" is defined in the Modern Management Technology Defined book as follows: "When I say terminatedly handle, I mean finishedly handle. That is handled, and that's all, boy! (HCL PL 4 May 68)." [REDACTED] this definition means that a SEA ORG member is take whatever action is necessary to handle a situation. These actions would include actions to "end the cycle" of enemies of the Church. Ending the cycle means to kill the people.

receiving the mission does not communicate that mission with
anyone. A person receiving the mission then goes to an area
where he does a "clay demo" of the mission. A "clay demo" is an
attempt to manifest verbal orders into physical form through the
manipulation of clay. It is a standard technique used in
Scientology. [REDACTED] it is common knowledge that if
any person fails to accomplish a mission, they are automatically
assigned to the RPF.

[REDACTED] normally missions issued to SEA ORG members of OSA US or OSA INT are issued by the HUBBARD COMMUNICATIONS OFFICE (HCO). When an individual is given a mission, all records concerning that individual are then pulled from the files and taken to an unknown location. Therefore, if an individual is arrested during the mission, the COS can deny that the person is in any way involved with the COS.

[REDACTED] the most flagrant criminal activity evident at the COS involves the SEA ORG members treatment of their children. [REDACTED]

[REDACTED] children below the age of six, who are left by their parents to sit in the hallway until someone comes by to attempt to care for them. These kids are left in tattered pajamas with little or nothing to eat. They are given inadequate sanitary changings, and are basically ignored. This conduct results because L. RON HUBBARD taught that children are simply

"thetans" in small bodies. Thetans are fully operational beings. Therefore, children must carry their own weight in the COS. [REDACTED] children of the COS are not educated at all. [REDACTED] state law mandates four hours of education. Therefore the children are often bussed to and from the "ranch." This is a three-hour round trip. This three hours contributes to the four-hour education time. The remaining hour is taken up with eating and exercise. Most children in the COS are functionally illiterate. [REDACTED] when children live at the ranch for alleged education, they are actually just put to physical labor. [REDACTED] the child reaches the age of six, he is then placed in the "CADET ORG" if his parents are SEA ORG members.

[REDACTED] it is common knowledge within the SEA ORG that while you cannot order the death of a SEA ORG member, you can order that member to participate in activity which deprives them of food and sleep, and requires constant exercise until that person dies. SEA ORG members believe that their seniors hold this power over them. This HUBBARD directive

while you are a member of the EPF, you can receive no mail or telephone communication from sources outside the EPF. Your only communication and contact is to be with your "Seniors."

[redacted] the goal of the COS is to "Clear" the entire planet. To "Clear" the entire planet means that the entire planet would become Scientologists. To "Clear" the planet also means that it will clear all the myths on the planet. These myths include the beliefs that national governments and leaders properly exercise authority over various groups of citizens. Members of the COS believe that only duly authorized Sea Org members can execute proper authority.

[redacted] children within the COS are treated with criminal neglect in many instances. COS philosophy dictates that children are fully operating individuals in small bodies. Therefore, children must pull their own weight. Quite often children are abandoned by their Sea Org parents [redacted]

[redacted] seen children sitting in hallways in their pajamas with a bowl of dry Cheerios before them or no food at all. This is where the parents of the children have left them while the parents perform their duties.

Children of Sea Org members receive virtually no formal education. At the age of six, these children become part of the "Cadet Org." Members of the Cadet Org are taken to a place called the "ranch" where they do hard physical labor, but they do not study. [redacted]

[redacted] the purpose of the "ranch" is to move children out of the public eye so that the COS cannot be disciplined by government agencies for their treatment of children. It is another attempt by the COS to maintain a good public image regarding something the public would perceive as wrong, but the church does not believe is wrong.
