On 5/25/84, Assistant United States Attorney (AUSA) [redacted] District Court of Appeals, WDC, was contacted with regard to the request set forth in above captioned airtel.

AUSA [redacted] advised that [redacted] was an unindicted co-conspirator in the case of U.S. v. MARY SUE HUBBARD in 1978. A review of FBI Washington Field Office files determined [redacted] was requested by the FBI, Washington Field Office to provide handwriting exemplars of [redacted] was also an unindicted co-conspirator. On 10/14/76, [redacted] provided nine (9) pages of exemplars of [redacted] On 9/23/77, [redacted] during an interview with FBI agents, WFO, advised [redacted] provided 9 pages of false handwriting exemplars to the FBI. According to [redacted] the Church of Scientology had planned to furnish false exemplars of his handwriting to the FBI.
